Observations:

- 1.- Already identified by Pentonville total lack of co-ordination of central F213 register in HHC. Is being addressed.
- 2.- Despite new system of recording incidents of self-harm still under-reporting levels significantly through IRS.
- 3.- Until recently no Observation books in HCC, therefore not possible to complete check of their books for entire period.

4.- C Wing's observation book covering period prior to 6 December could not be found during audit therefore the wing figures are distorted by this.

5.- Overall good follow-up of issues in wing observation books.

6.- Figures for F2052SH 's being opened only refer to incidents where the prisoner is recorded as actually self-harming and the book being opened. I have not included those situations where the prisoner has threatened to self-harm or where staff have concerns. Neither of these would necessarily appear elsewhere for reporting purposes.

7.- Noticable improvement in co-ordination in latter part of audit period due to new reporting procedures being introduced at Pentonville. However still place for further improvement.

8. -- Comparatively high figures for D wing compared to other wings but this wing does contain the first night centre and probably sees the largest movement of prisoners on a daily basis.
